A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING SETTLEMENT OF MELANIE WILSON

WHEREAS, on May 13, 2016, Plaintiff Melanie Wilson filed suit against the City of San Diego [City] alleging personal injuries arising from her interaction with former San Diego Police Officer Christopher Hays which occurred on December 23, 2013. The suit is entitled *Melanie* Wilson v. Christopher Hays and the City of San Diego, Case No. 16cv1161 BAS (DHB); and

WHEREAS, in closed session on June 20, 2017, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, none, approved the settlement of Melanie Wilson's claim for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in a settlement agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

- 1. The Mayor or his designee to pay the sum of \$250,000 from the Public Liability Fund 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury claim of Melanie Wilson, United States District Court Case No. 16cv1161 BAS (DHB).
- 2. The Chief Financial Officer to appropriate and expend \$250,000 from the Public Liability Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer;

3. Authorizes the Comptroller to issue two	separate checks. One check made payable to
the Gilleon Law Firm in the sum of \$175,000.00;	and one check in the sum of \$75,000.00, made
payable to the Mutual of Omaha Structured Settle	ement Company on behalf of Plaintiff Melanie
Wilson.
