DATE OF FINAL PASSAGE OCT 10 2017

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING CALIFORNIA COASTAL COMMISSION SUGGESTED MODIFICATIONS TO THE SAN YSIDRO COMMUNITY PLAN AND LOCAL COASTAL PROGRAM AND ADOPTING AMENDMENTS TO THE SAN YSIDRO COMMUNITY PLAN AND LOCAL COASTAL PROGRAM.

WHEREAS, on November 15, 2016, the City Council of the City of San Diego held a public hearing for the purpose of considering amendments to the San Ysidro Community Plan, the General Plan and Implementation Plan, and other actions associated with the comprehensive update to the 1990 San Ysidro Community Plan and Local Coastal Program; and

WHEREAS, on November 15, 2016, the City Council of the City of San Diego adopted and recommended certification to the California Coastal Commission of the San Ysidro Community Plan and Local Coastal Program update; and

WHEREAS, the California Coastal Act (Public Resources Code section 30000 et seq.) requires California Coastal Commission certification of a land use plan of a proposed local coastal program; and

WHEREAS, on May 11, 2017, the California Coastal Commission approved the San Ysidro Community Plan and Local Coastal Program update with suggested modifications that address the protection of environmentally sensitive habitat area (ESHA) and wetlands with the potential development of a new road, and Commission action resulted in the adoption of several significant policies that will adequately protect ESHA and wetlands in all future development; and

WHEREAS, on May 24, 2017, the California Coastal Commission transmitted, in writing, to the City of San Diego, the suggested modifications for adoption by the Council of the City of San Diego; and


WHEREAS, on October 3, 2017, the City Council considered the California Coastal Commission suggested modifications; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That this City Council approves the California Coastal Commission suggested modifications to the Council-adopted San Ysidro Community Plan and Local Coastal Program.
2. That the City Council adopts amendments to the San Ysidro Community Plan and Local Coastal Program that implement the comprehensive update thereto, and that it adopts corresponding amendments to the General Plan, with a copy of said update being on file in the office of the City Clerk as Document No. RR - 311341.
3. That after adoption, the Mayor or his designee is authorized to submit this Resolution to the California Coastal Commission for final certification and incorporation into the City's certified Local Coastal Program.

BE IT FURTHER RESOLVED, that this Resolution shall take effect and be in force after its final passage, except that the provisions of this Resolution inside the Coastal Overlay Zone, which are subject to California Coastal Commission jurisdiction as a City of San Diego Local Coastal Program amendment shall not take effect until the date the California Coastal Commission unconditionally certifies those provisions as a local coastal program amendment.



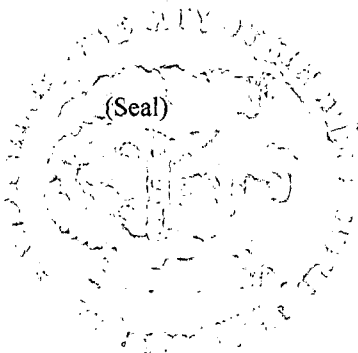
