A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING REVISIONS TO THE CITY'S CITIZEN PARTICIPATION PLAN RELATING TO FOUR U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) ENTITLEMENT PROGRAMS.

WHEREAS, the City of San Diego (City) is an entitlement jurisdiction that annually receives federal funds through the following four U.S. Department of Housing and Urban Development (HUD) housing and community development entitlement programs: Community Development Block Grant, HOME Investment Partnerships, Emergency Solutions Grants, and Housing Opportunities for Persons with AIDS (collectively, HUD Programs); and

WHEREAS, pursuant to Title 24 Code of Federal Regulations section 5.154(b), the City must periodically prepare and submit to HUD an Assessment of Fair Housing (AFH); and

WHEREAS, the City is expected to submit its next AFH to HUD in fall 2018; and

WHEREAS, Title 24 Code of Federal Regulations section 5.158(a)(1) provides that the City must follow the policies and procedures in its citizen participation plan in developing an AFH to ensure that the AFH is informed by meaningful community participation; and

WHEREAS, the City prepared and submitted to HUD the City's citizen participation plan (Participation Plan) relating to the HUD programs before August 17, 2015; and

WHEREAS, Title 24 Code of Federal Regulations section 91.105(a) requires the City to amend the Participation Plan to conform with revisions to the HUD regulations governing the Participation Plan in reference to development of the AFH that became effective on August 17, 2015, and the City is proposing such revisions to the Participation Plan; and

WHEREAS, in Fiscal Year 2011, the City established a Consolidated Plan Advisory Board (CPAB) to serve in an advisory capacity to the Mayor, City Council, and City management on policy issues relating to the HUD–required Consolidated Plan and provide recommendations regarding the allocation of HUD Programs funding; and

WHEREAS, the CPAB held public meetings on May 10, 2017, August 8, 2017, and September 13, 2017, to receive public comments about the draft revised Participation Plan; and

WHEREAS, at the CPAB meeting on September 13, 2017, the CPAB voted to recommend the City Council’s approval of the revised Participation Plan; and

WHEREAS, the draft revised Participation Plan was released on August 23, 2017, for a 30 calendar day public comment and review period; and

WHEREAS, since August 23, 2017, the draft revised Participation Plan has been available for public review on the City’s website (www.sandiego.gov/cdbg) and at the following City libraries and community facilities: Central Library, Malcolm X Library, San Ysidro Library, Logan Heights Library, City Heights/Weingart Library, Bayside Community Center, and the Jacobs Center for Neighborhood Innovation; and

WHEREAS, the public comment and review period for the draft revised Participation Plan concluded on September 22, 2017; and

WHEREAS, on October 10, 2017, the City Council conducted a public meeting to receive public comments about the draft revised Participation Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. The revised Participation Plan is approved in substantially the form submitted with the docket material accompanying this Resolution.

2. The Mayor, or designee, is authorized to make non-substantive revisions to the Participation Plan to finalize such plan and ensure that all public comments about such plan received by the City during the 30 calendar day public comment and review period are included in the final plan.

3. The Mayor, or designee, is further authorized to submit the final revised Participation Plan to HUD for approval.



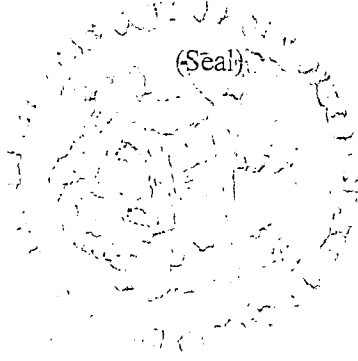
