A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING APPLICATION FOR PROPOSITION 1 GRANT FUNDING FOR THE GROUNDWATER SUSTAINABILITY PLAN FOR THE SAN PASOUAL VALLEY GROUNDWATER BASIN.

WHEREAS, the California Department of Water Resources (DWR) is administering the 2017 Sustainable Groundwater Planning Grant Program (SGPGP) using funds authorized by the Water Quality, Supply, and Infrastructure Improvement Act of 2014, (Proposition 1), to encourage sustainable management of groundwater resources that support the Sustainable Groundwater Management Act (SGMA); and

WHEREAS, the proposed Groundwater Sustainability Plan (GSP) for the San Pasqual Valley Groundwater Basin (Basin) is a Category 2, Tier 2 project eligible for a maximum grant amount of \$1 million; and

WHEREAS, the City of San Diego (City) desires to adopt a resolution to submit an application to DWR to obtain grant funding under the 2017 SGPGP and Proposition 1, and to enter into an agreement to receive grant funding for the GSP for the Basin; and

WHEREAS, on June 27, 2017, Council held a public hearing and approved a resolution (R-311212) to approve the MOU between the City and the County of San Diego for the Basin to eliminate any individual overlap between each agency; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that application be made to the California Department Water Resources to obtain a grant under the 2017 Sustainable Groundwater Planning Grant Program pursuant to the Water Quality, Supply, and Infrastructure Improvement Act of 2014 (Proposition 1) (Water Code Section 79700 et seq.), and to enter into

an agreement to receive a grant for the: Groundwater Sustainability Plan (GSP) for the San Pasqual Valley Groundwater Basin. The Mayor of the City of San Diego, or designee, is hereby authorized and directed to prepare the necessary data, conduct investigations, file such application, and execute a grant agreement with California Department of Water Resources.

BE IT FURTHER RESOLVED, that the Mayor or designee, is authorized to conduct all negotiations, execute and submit all documents including but not limited to applications, agreements, along with any amendments thereto, and payment requests, which may be necessary for the completion of the GSP for the Basin.

BE IT FURTHER RESOLVED, that the Mayor or designee is authorized to apply for, accept, and execute an agreement, along with any amendments thereto, for the 2017 SGPGP pursuant to Proposition 1, for the GSP for the Basin in an amount not to exceed \$1,000,000.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept, appropriate and expend an amount not to exceed \$1,000,000 from the California Department of Water Resources under the 2017 SGPGP pursuant to Proposition 1, if grant funding is secured.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to establish a special interest-bearing account for the grant, if required.
