"BUDGET POLICY."


WHEREAS, in a report dated October 5, 2017, regarding Revisions to the Budget Policies, (CP 000-02) and Reserve Policy, (CP 100-20) (Report), the Chief Financial Officer recommended revising the Budget Policy, generally, by changing the language regarding the timing of the Mid-Year Budget Report to allow for flexibility and streamlining with respect to preparation and dissemination of the mid-year budget projections and to update other language on the Budget Policy as set forth in the Report; and

WHEREAS, this proposal was presented to the Budget and Government Efficiency Committee (Committee), on October 25, 2017, and the Committee voted to approve the recommendations in the Report; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that Council Policy 000-02 entitled "Budget Policy" is revised as set forth in the Council Policy filed in the Office of the City Clerk as Document No. RR-311415.

BE IT FURTHER RESOLVED, that the City Clerk is instructed to update the Council Policy Manual to include revised Council Policy 000-02.
