A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SECOND AMENDMENT TO THE COOPERATIVE PROCUREMENT CONTRACT BETWEEN THE CITY OF SAN DIEGO AND HP, INC. FOR COMPUTER EQUIPMENT.

WHEREAS, in 2015, the National Association of State Procurement Officials (NASPO), through lead agency the State of Minnesota, as part of a cooperative procurement process, issued an RFP for computer equipment and awarded a contract identified as Master Agreement No. MNWNC-115 (Master Agreement) to the Hewlett Packard Company (HPC) which, after HPC split into two corporations, was subsequently assigned to two separate companies, with Desktops, Laptops and Tablets, including related peripherals and services, assigned to HP, Inc. as Agreement No. MNNVP-133; and

WHEREAS, on September 29, 2015, the State of California entered into Participating Addendum No. 7-15-70-34-001 for participation in the Master Agreement; and

WHEREAS, as provided for in Section 22.3208 of the San Diego Municipal Code, the City's Purchasing Agent certified in writing that use of the MNNVP-133 cooperative procurement contract was in the City's best interests, to the City's economic advantage, and the agency's contract was awarded using a process that complies with the City's policies, rules, and regulations, resulting in a contract between the City and Contractor (Contract); and

WHEREAS, the First Amendment to the Contract was executed on March 29, 2017 to extend the term of the Agreement to March 31, 2020; and

WHEREAS, the Parties now wish to enter into the Second Amendment to the Contract to increase the not to exceed amount to a total of \$5,100,000 while otherwise keeping intact the same terms and conditions; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to approve the resolution to execute, for and on behalf of the City, the Second Amendment to the Cooperative Procurement Contract between the City of San Diego and HP, Inc. for the provision of as-needed computer equipment, to increase the not-to-exceed amount of the Contract to \$5,100,000, and otherwise modify the Contract pursuant to the terms and conditions contained in the Second Amendment to the original Contract on file with the Office of the City Clerk as Document No. RR-2311418

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,100,000 over the full term of the Contract, including any options to renew, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.
