A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DENYING THE APPEAL OF THE HISTORICAL DESIGNATION OF THE GORDON B. WELLS/ALLEN H. HILTON BUNGALOW COURT APARTMENTS LOCATED AT 1525-1537 UNION STREET, AND UPHOLDING THE DECISION OF THE HISTORICAL RESOURCES BOARD TO DESIGNATE THE PROPERTY AS A HISTORICAL RESOURCE.

WHEREAS, on August 24, 2017, the San Diego Historical Resources Board (HRB) designated the Gordon B. Wells/Allen H. Hilton Bungalow Court Apartments located at 1525-1537 Union Street, San Diego, California, as a historical resource under the Criterion C and Criterion D; and

WHEREAS, on appeal the City Council may by resolution uphold, overturn, or modify the determination of the HRB; and

WHEREAS, on appeal the City Council may reject the HRB's designation of a property as a historical resource on the basis of factual errors in materials or information presented to the HRB violations of bylaws or hearing procedures by the HRB or individual member, or presentation of new information; and

WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter required the City Council to act as a quasi-judicial body where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the appeal of Gordon B. Wells/Allen H. Hilton Bungalow Court Apartments, located at 1525-1537 Union Street, as a designated historical resources is denied, the decision of the Historical Resources Board is upheld and that the Gordon B. Wells/Allen H. Hilton Bungalow Court Apartments, located at 1525-1537 Union Street, is designated a historical resource.
