

ORDINANCE NUMBER O- 20907 (NEW SERIES)

DATE OF FINAL PASSAGE FEB 28 2018

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF AN AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND ZENSAR TECHNOLOGIES IM, INC. FOR NETWORK SERVICES.

WHEREAS, in May 2017, the City of San Diego (City) issued Request for Proposal (RFP) No. 10087192-17-H to solicit bids for vendors to provide the City with network (data and voice) services; and

WHEREAS, after an extensive evaluation of qualified proposals, Zensar Technologies IM, Inc. (Zensar) was selected to be awarded the contract; and

WHEREAS, this action requests the approval of an Ordinance to authorize the Mayor or his designee to execute a Master Services Agreement for network services with Zensar (Agreement) for a term of up to 123 months (10.25 years), consisting of an initial period of up to 51 months (which includes a start-up period of up to 3 months and 48 months of steady state services), options for the City to extend for two additional two-year terms of steady state services, and a disentanglement period of up to 24 months; and

WHEREAS, the total authorized spending requested for the Agreement is an amount not-to-exceed \$79,638,531; and

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, the Agreement between the City of San Diego and Zensar Technologies IM, Inc. for Network Services pursuant to the terms and conditions contained in the original Agreement on file in the Office of the City Clerk as Document No. OO- 20907.


Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$79,638,531 over the full term of the Agreement for funding network services, contingent upon adoption of the annual Appropriation Ordinance for the applicable fiscal year, and upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasury.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
