AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO CHANGING 3.6 ACRES LOCATED NORTHEAST OF PACIFIC HIGHLANDS RANCH PARKWAY BETWEEN CARMEL VALLEY ROAD AND VILLAGE WAY, WITHIN THE PACIFIC HIGHLANDS RANCH SUBAREA PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, FROM THE AR-1-1, RT-1-2, RX-1-1 AND CC-1-2 ZONES INTO THE CC-1-3 ZONE, AS DEFINED BY SAN DIEGO MUNICIPAL CODE SECTION 131.0507; AND REPEALING ORDINANCE NO. 18580 (NEW SERIES), ADOPTED SEPTEMBER 8, 1998, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

WHEREAS, under Charter section 280(a)(2) this ordinance is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body and where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on evidence presented; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

(O-2018-84)

Diego Municipal Code Chapter 13 Article 1 Division 5. This action amends the Official Zoning

Map adopted by Resolution R-301263 on February 28, 2006.

Section 2. That Ordinance No. 18580 (New Series), adopted September 8, 1998, of

the ordinances of the City of San Diego is repealed insofar as the same conflict with the rezoned

uses of the land.

Section 3. That a full reading of this ordinance is dispensed with prior to its final

passage, a written or printed copy having been available to the City Council and the public a day

prior to its final passage.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from

and after its passage, and no building permits for development inconsistent with the provisions of

this ordinance shall be issued unless application therefor was made prior to the date of adoption

of this ordinance.

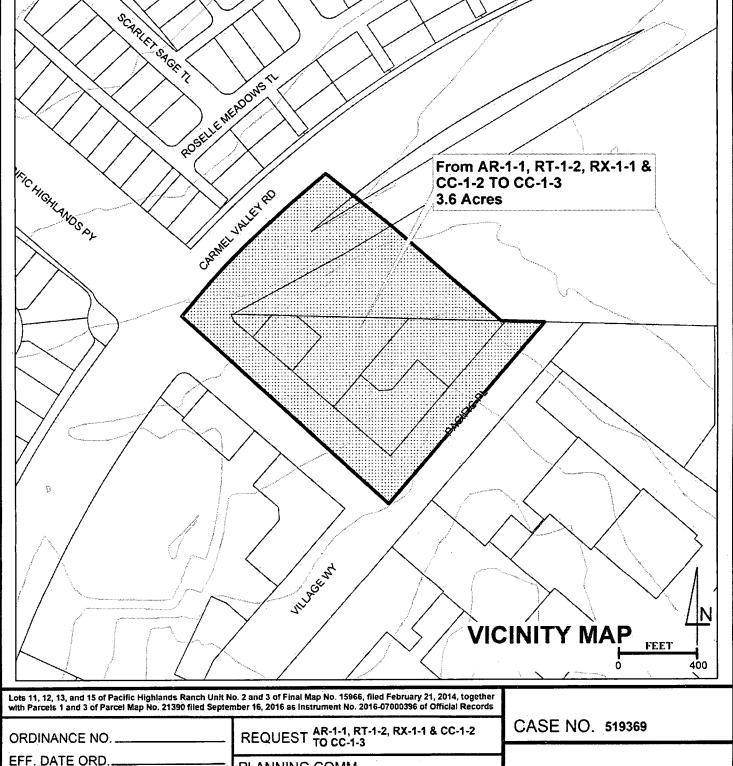
