ORDINANCE NUMBER O- 20933 (NEW SERIES)

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AMENDMENT NO. 1 TO THE AGREEMENT WITH U.S. PEROXIDE, LLC FOR THE PEROXIDE REGENERATED IRON-SULFIDE CONTROL (PRI-SCTM) AND PEROXIDE REGENERATED IRON-CHEMICALLY ENHANCED TREATMENT (PRI-CEPTTM) PROGRAM.

WHEREAS, the City and U.S. Peroxide, LLC. dba USP Technologies entered into an Agreement to provide the Peroxide Regenerated Iron-Sulfide Control (PRI-SCTM) and Peroxide Regenerated Iron-Chemically Enhanced Primary Treatment (PRI-CEPTTM) services for various locations within the Metro Wastewater System, and approved by Council Resolution No. R-308108, dated April 16, 2013; and

WHEREAS, the City's existing MOA has exercised its fourth and final option year (April 14, 2017 – April 15, 2018). In accordance with SDMC §22.3016 and in adherence with City guidelines, Public Utilities Department (PUD) has received sole source authorization No. 3956 in order to amend the USP contract term for continued use of the PRI-SCTM and PRI-CEPTM patented program; and

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized, except by Ordinance adopted by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is hereby authorized and empowered to execute, for and on behalf of said City, Amendment No. 1 to the Agreement with U.S. Peroxide, LLC, dba USP Technologies (USP) for the continued use of the PRI-SCTM and PRI-CEPTTM Program in amount not to exceed \$7,003,750, for the first contract year with four (4) one (1) year options, for a cumulative total not to exceed \$38,700,141, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. OO-

20933

Section 2. That the Chief Financial Officer is authorized to expend a cumulative amount not to exceed \$38,700,414 on an as-required basis over the term of the contract of one (1) year and four (4) one (1) year options, from Metro Sewer Utility Fund 700001, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its final passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
