AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF THE SECOND AMENDMENT TO THE AGREEMENT WITH ATOS IT SOLUTIONS AND SERVICES, INC. FOR DATA CENTER, SERVICE DESK AND DESKTOP SERVICES.

WHEREAS, on May 23, 2012, the City Council approved Resolution No. R-307432-1 which authorized the execution of a Master Services Agreement with Atos IT Solutions and Services, Inc. for Data Center, Service Desk and Desktop Services (Agreement); and

WHEREAS, final passage of Ordinance No. O-20911, which authorized execution of a First Amendment to the Agreement occurred on April 4, 2017 and the First Amendment became effective on April 7, 2017; and

WHEREAS, the parties desire to enter into a Second Amendment to the Agreement to extend the term of the Agreement, increase the not to exceed amount and otherwise modify the Agreement pursuant to the terms and conditions of the Second Amendment to the Agreement; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is hereby authorized to execute, for and on behalf of the City, the Second Amendment to the Master Services Agreement with Atos IT Solutions & Services, Inc., for the purpose of extending the term of the Agreement through June 30, 2020, with a disentanglement period of up to an additional twenty-four months, increasing

the not-to-exceed amount of the Agreement to \$103,768,700 and otherwise modifying the

Agreement pursuant to the terms and conditions contained in the Second Amendment to the

Agreement on file in the Office of the City Clerk as Document No. OO-

Section 2. That the Chief Financial Officer is authorized to expend an amount not to

exceed \$103,768,700 during the term of the Master Services Agreement with Atos IT Solutions

& Services, Inc., as amended, for the purpose of funding the Agreement contingent upon the

adoption of the annual Appropriation Ordinance for the applicable fiscal year and contingent

upon the Chief Financial Officer furnishing one or more certificates certifying that funds

necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a

written or printed copy having been made available to the City Council and the public prior to

the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from

and after its final passage.
