AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO CONTRIBUTION AGREEMENT WITH SAN DIEGO ASSOCIATION OF GOVERNMENTS (SANDAG) FOR THE UTC TRANSIT CENTER DIEGO.

WHEREAS, this action constitutes the City's contribution of \$4 million of funds from the North University City Public Facilities Financing Plan to the San Diego Association of Governments (SANDAG) for construction of the University Towne Centre (UTC) Transit Center (Project); and

WHEREAS, the UTC Transit Center was recently constructed and opened to public use on October 27, 2017 on the property of Westfield UTC shopping center in accordance with the provisions of Tentative Map No. 293788, Conditions 56 and 57, and with Site Development Permit 293783, Requirements 121 through 128, approved by City Council on July 29, 2008 which the Transit Center serves regional bus routes, provides parking for transit users, and will have an accessible pedestrian connection to the loading platform of the San Diego Trolley station that will be constructed as part of SANDAG's Mid-Coast Transportation Corridor project; and

WHEREAS, the construction cost of the Transit Center was estimated at \$13.7 million in 2012 with this estimate including contributions of \$5.7 million from SANDAG, \$4.0 million from Westfield, and \$4.0 million from the City which the City's contribution is entirely funded by the North University City Facilities Benefit Assessment (FBA) funds which have been collected for this purpose and this project is included as Project NUC-M in the North University City Public Facilities Financing Plan adopted by City Council on June 12, 2012; and

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an ordinance to enter into a Contribution Agreement with SANDAG for the purpose of constructing the UTC Transit Center, in an amount not to exceed \$4,000,000, under the terms and conditions set forth in the Agreement, on file in the Office of the City Clerk as Document No. OO- 20945.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$4,000,000 from IO 13001941, NUC-M UTC Transit Center, Fund 400080, North University City Facilities Benefit Assessment (FBA), for the City's contribution to construction of the UTC Transit Center, contingent upon adoption of the Annual Appropriation Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer furnishing one or more certificates certifying that the funds necessary for expenditures are, or will be, on deposit with the City Treasury.

Section 3. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
