DATE OF FINAL PASSAGE JUL 27 2018

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXTENSION OF AGREEMENT PAST FIVE YEARS WITH J.R. FILANC CONSTRUCTION COMPANY, INC. FOR CONSTRUCTION OF THE MBC DEWATERING CENTRIFUGES REPLACEMENT PROJECT.

WHEREAS, in May 2013, the City of San Diego awarded a design/build contract with J. R. Filanc Construction Company, Inc. for the construction of the MBC Dewatering Centrifuges Replacement project (Project);

WHEREAS, the Project has been subjected to several delays during design and construction, City and Filanc agree to extend the agreement by two (2) years until June 6, 2020;

WHEREAS, under Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee, is authorized to execute, for and on behalf of said City, Change Order # 3 to extend the contract for an additional 24 months not to exceed a total of seven years for contract K13-5573-DB2-3 for WBS No. S-00339, MBC Dewatering Centrifuges Replacement Project under the terms and conditions set forth in Change Order # 3, on file in the office of the City Clerk as Document No. OO 20964

Section 2. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
