AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF AMENDMENTS TO THE NON-EXCLUSIVE SOLID WASTE MANAGEMENT FRANCHISE AGREEMENTS FOR SOLID WASTE COLLECTION SERVICES PROVIDED IN THE CITY BY PRIVATE FRANCHISED HAULERS AND APPROVAL OF INCREASES TO FRANCHISE FEES PAYABLE TO THE CITY.

WHEREAS, in September 2000, a two-tier Non-Exclusive Solid Waste Collection Franchise system was established to reflect the difference in market share served by the franchised haulers; and

WHEREAS, Class II franchises have been granted to EDCO Disposal Corporation, Republic Services, and Waste Management, Inc. (and their affiliates), and several Class I franchises have been granted for hauling of the remaining commercial waste as listed on Exhibit A); and

WHEREAS, fees for the franchises are set by resolution, and fees for Class I franchises are currently \$15 per ton, and fees for Class II franchises are \$16 per ton; and

WHEREAS, the franchise fees were last increased in 2009 and solid waste market conditions and environmental and regulatory conditions have changed in the intervening period, warranting adjustments to fees to be set by resolution and to provisions of the agreements relating to term and termination, waste diversion, facilities for waste diversion, recycling credits, and alternative fueled vehicles; and

WHEREAS, the City and its franchised commercial solid waste haulers desire to amend the non-exclusive franchise agreements at this time to modify provisions of the agreements

relating to term and termination; waste diversion requirements, facilities for waste diversion; third party recycling credits; and use of alternative fueled vehicles; and

WHEREAS, under Charter section 103, no franchise or extension thereof may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, Tenth Amendments to the Class I Non-Exclusive Franchise Agreements for Solid Waste Management Services with the Class I franchisees listed on the attached Exhibit A, under the terms and conditions set forth in the Tenth Amendment on file in the Office of the City Clerk as Document No. OO-20999

Section 2. That the Mayor or his designee is authorized to execute, for and on behalf of the City, Ninth Amendments to the Class II Non-Exclusive Franchise Agreements for Solid Waste Management Services with the Class II franchisees listed on the attached Exhibit A, (except for EDCO Disposal Corporation dba Daily Disposal Services, Inc.), under the terms and conditions set forth in the Ninth Amendment on file in the Office of the City Clerk as Document No. OO- 20993

Section 3. That the Mayor or his designee is authorized to execute, for and on behalf of the City, an Eighth Amendment to the Class II Non-Exclusive Franchise Agreement for Solid Waste Management Services with EDCO Disposal Corporation dba Daily Disposal Services, Inc., under the terms and conditions set forth in the Eighth Amendment on file in the Office of the City Clerk as Document No. OO-20395-3

Section 4. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.
