WHEREAS, the Council approved merging the Office of the City Comptroller and the Financial Management Department into a new Department of Finance by San Diego Ordinance

O-21001 passed on 007 23 2018; and

WHEREAS, the Council approved establishing a new Office of Boards and Commissions by San Diego Ordinance O- 21,003 passed on (CT 23 2018); and

WHEREAS, the Council approved changing the name of the Intergovernmental Relations

Department to the Government Affairs Department by San Diego Ordinance O
passed on 001 23 2018; and

WHEREAS, the Council approved establishing a new Sustainability Department by San Diego Ordinance O- 21,000 passed on 007 23 2018; and

WHEREAS, the Mayor recommends updating the list of all City departments in

Division 18 of the Administrative Code to reference the new Finance Department, Office of

Boards and Commissions, Government Affairs Department, and Sustainability Department; and

WHEREAS, under San Diego Charter section 26, the Council must approve changes to the Administrative Code by an affirmative vote of two-thirds of the Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 2, Article 2, Division 18 of the San Diego Municipal Code is amended by amending section 22.1801 to read as follows:
