ORDINANCE NUMBER O- 21013 (NEW SERIES)

DATE OF FINAL PASSAGE NOV 14 2018

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF THE FIRST AMENDMENT TO THE AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND SPINIFEXIT NORTH AMERICA, INC., FOR SOFTWARE LICENSING AND SUPPORT SERVICES.

WHEREAS, on December 26, 2013, the City of San Diego entered into an Agreement for Services with SpinifexIT North America, Inc. for two (2) licensed software solutions, Easy Reporter and Easy Helpdesk, to assist with expediting responses to satisfy reporting requirements and to assist staff in answering employee payroll questions (Agreement); and

WHEREAS, the Department of Information Technology is requesting approval of an Ordinance authorizing the Mayor or his designee to execute the First Amendment to the Agreement for Services with SpinifexIT North America, Inc., to extend the Agreement for a term of up to an additional seven (7) years and increase the not to exceed amount by \$221,795; and

WHEREAS, under Charter section 99, no contract, agreement, or obligation extending for a period of more than five years may be authorized except by Ordinance approved by a two-thirds majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is hereby authorized to execute, for and on behalf of the City, the First Amendment to the Agreement for Services between the City of San Diego and SpinifexIT North America, Inc., for software licensing and support services, for the purpose of increasing the not to exceed by an amount of \$221,795 for a total not to exceed amount of \$461,795, and extending the term of the Agreement for up to an additional seven (7) years, and otherwise modifying the Agreement pursuant to the terms and conditions contained in


the First Amendment to the original Agreement on file with the Office of the City Clerk as Document No. OO- **21013** .

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$461,795 over the full term of the Agreement, as amended, including any options to renew, contingent upon the adoption of the Annual Appropriation Ordinance for the applicable fiscal year and contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That a full reading of this ordinance is dispensed with prior to passage, a written copy having been made available to the Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.

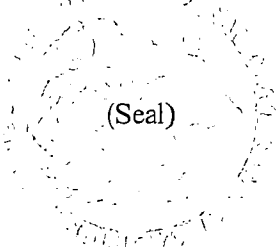

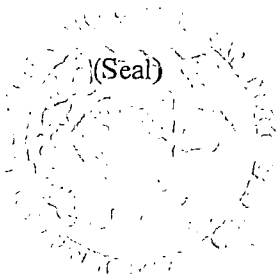
