AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING TO EXECUTE THE FIRST AMENDMENT AGREEMENT WITH MERKEL & ASSOCIATES, INC. FOR THE MISSION BAY NAVIGATIONAL SAFETY DREDGING PROJECT.

WHEREAS, in June 13, 2016, the City of San Diego, acting by and through its Mayor pursuant to San Diego Municipal Code section 22.3207, approved approximately \$303,860 of financing for environmental support services of the Mission Bay Navigational Safety Dredging project; and

WHEREAS, Merkel & Associates, Inc. was selected in accordance with San Diego Municipal Code section 22.3108, and entered into an agreement with the City of San Diego on June 13, 2016, Contract No. H166675; and

WHEREAS, the proposed first amendment to the agreement with Merkel & Associates, Inc. is required for completing environmental review, permitting and technical support services extending the original contract duration from 5 years to 7 years;

WHEREAS, under San Diego Charter section 99, no contract, agreement or obligation extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds' majority vote of the City Council; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor, or his designee is hereby authorized and empowered to execute, for and on behalf of said City, the First Amendment to an agreement with Merkel & Associates, Inc. for the purpose of completing the environmental review, permitting and technical support services extending the original contract duration from 5 years to 7 years in CIP

in an amount not to exceed \$492,434 the under the terms and conditions set forth in the

project scope or cost and which the Mayor shall deem necessary from time to time in order to

carry out the purposes and intent of this project and agreement.

Section 2. That the expenditure of an amount not to exceed \$492,434 from CIP A-

GF.00004, Mission Bay Improvements (B-10163, Mission Bay Navigational Safety Dredging),

Fund 200386, Mission Bay Park Improvement Fund, is authorized for the purpose of executing

this amendment to the agreement.

Section 3. That the Chief Financial Officer, upon advice from the administering

department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a

written or printed copy having been made available to the City Council and the public prior to

the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from

and after its final passage.
