A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AS-NEEDED AGREEMENT WITH ENVIRONMENTAL SCIENCE ASSOCIATES FOR ENVIRONMENTAL CONSULTING SERVICES, AND RELATED FUNDING ACTIONS.

WHEREAS, the City of San Diego's (City) Transportation and Storm Water Department requires the as-needed consulting services of an environmental consulting firm in order to support implementation and monitoring of various Storm Water Division flood management programs and to supplement the City's efforts to comply with applicable federal, state, and local regulatory requirements, including the requirements of the 2013 Municipal Separate Storm Sewer System Permit (MS4 Permit) (the Consulting Services); and

WHEREAS, in February 2017, in conformance with San Diego Municipal Code section 22.3207, Council Policy 300-7, and Administrative Regulation 25.60, the City advertised a Request for Proposals for the Consulting Services, and received seven responsive proposals; and

WHEREAS, Environmental Science Associates (ESA) was selected as one the two most highly qualified firms to provide the Consulting Services, subject to City Council approval; and

WHEREAS, the Environment Committee heard this item on December 7, 2017, and recommended that the City Council approve the contract award (Agreement) to ESA; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute, for and on behalf of the City, an agreement with ESA for

as-needed environmental consulting services, for a period of five years, in an amount not to exceed \$7,500,000, under the terms and conditions set forth in the Agreement on file with the City Clerk as Document No. RR
311487

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend a total amount not to exceed \$7,500,000 from the Storm Water Division's Operating Budget (211612) for FY 2018-2023, solely and exclusively to provide funds for this Agreement, contingent on City Council approval of the annual Appropriations Ordinance for the applicable fiscal year, and upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$1,000 from FY 2018 General Fund (100000) Storm Water Division Operating Budget (211612) for the purpose of executing this Agreement and meeting the minimum contract requirements.
