- 2. The Chief Financial Officer to appropriate and expend \$175,000.00 from the Public Liability Fund No. 720045, continent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
