DATE OF FINAL PASSAGE JAN 31 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING AN AMENDMENT TO THE OTAY MESA COMMUNITY PLAN AND AMENDING THE GENERAL PLAN RELATED TO THE ADOPTION OF THE VERNAL POOL HABITAT CONSERVATION PLAN.

WHEREAS, on January 22, 2018, the City Council of the City of San Diego held a public hearing for the purpose of considering amendments to the Otay Mesa Community Plan and General Plan and other actions associated with adoption of the Vernal Pool Habitat Conservation Plan; and

WHEREAS, the amendments to the Otay Mesa Community Plan revise land use maps to include expanded multiple habitat planning area boundaries and revise policies related to the protection, preservation, and long-term management of vernal pool resources; and

WHEREAS, as part of the amendments, the City's General Plan will be amended due to the Community Plan being part of the adopted General Plan; and

WHEREAS, the Planning Commission of the City of San Diego held a public hearing on October 19, 2017, to consider the amendments to the Otay Mesa Community Plan and recommended adoption of the amendments; and

WHEREAS, the City Council has considered the Planning Commission record and recommendation as well as the maps, exhibits, and written documents contained in the file for this amendment on record in the City of San Diego, and has considered the oral presentations given at the public hearing; NOW, THEREFORE,

BE IT RESOLVED, that the City Council of the City of San Diego hereby adopts the amendments to the Otay Mesa Community Plan, and amends the General Plan, with a copy of

said amendments being on file in the office of the City Clerk as Document No. RR-

BE IT FURTHER RESOLVED, that prior to becoming effective, this Resolution shall be submitted to the San Diego County Regional Airport Authority (SDCRAA) for a consistency determination.

That if the SDCRAA finds this Resolution consistent with the Airport Land Use Compatibility Plan (ALUCP) for the Brown Field Airport, this Resolution shall take effect and be in force as of the date of the finding of consistency by SDCRAA.

That if the SDCRAA determines that this Resolution is inconsistent or conditionally consistent, subject to proposed modifications, with the ALUCP for the Brown Field Airport, the Resolution shall be submitted to the City Council for reconsideration.


That if the SDCRAA determines that this Resolution is conditionally consistent with the ALUCP for the Brown Field Airport, but that consistency is subject to proposed modifications, the City Council may amend this Resolution to accept the proposed modifications, and this Resolution as amended shall take effect and be in force after its final passage.

That a proposed decision by the City Council to overrule a determination of inconsistency or to reject the proposed modifications for a finding of conditional consistency shall include the findings required pursuant to Public Utilities Code section 21670 and require a two-thirds vote; the proposed decision and findings shall be forwarded to the SDCRAA, California Department of Transportation, Division of Aeronautics, and the airport operators for the Brown Field Airport; and the City Council shall hold a second hearing not less than forty-five days from the date the proposed decision and findings were provided, at which hearing any

comments submitted by the public agencies shall be considered and any final decision to overrule a determination of inconsistency shall require a two-thirds vote.

That if the City Council makes a final decision to overrule a determination of inconsistency, this Resolution shall take effect and be in force on the thirtieth day from and after its final passage.
