A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING AMENDMENTS TO THE LAND DEVELOPMENT MANUAL BIOLOGY GUIDELINES.

WHEREAS, San Diego Municipal Code Section 111.0106 provides that the City may establish and adopt submittal requirements, review procedures, and standards and guidelines for development to supplement the Land Development Code to be known as the Land Development Manual; and

WHEREAS, the City Council of the City of San Diego (Council) adopted Biology Guidelines as part of the Land Development Manual by Resolution No. R-293254 on June 6, 2000; and

WHEREAS, amendments to the Environmentally Sensitive Lands Regulations in the Land Development Code are proposed, which include the recognition of the Vernal Pool Habitat Conservation Plan (VPHCP) as a complimentary document to the Multiple Species Conservation Program (MSCP) and establishment of development regulations inside and outside the Coastal Zone for projects impacting vernal pool resources; and

WHEREAS, amendments to the Land Development Manual Biology Guidelines, on file in the Office of the City Clerk as Document No. RR-311507 are proposed to establish criteria standard mitigation ratios for projects impacting vernal pools, establish management and monitoring responsibilities for vernal pool resources in accordance with the VPHCP, and recognition of the VPHCP as a complimentary document to the MSCP; NOW, THEREFORE,
