DATE OF FINAL PASSAGE JAN 31 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING FUNDS TO THE URBAN CORPS OF SAN DIEGO COUNTY FOR THE FIRST ANNUAL LA VUELTA END OF SUMMER CULTURAL FESTIVAL, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING OF ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DESCRETIONARY TRANSIENT OCCUPACY TAX ALLOCATION.

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, titled, "City Council Funding Of Arts, Culture and Community Festivals With Discretionary Transient Occupancy Tax Allocation" on August 13, 2012, by Resolution R-307625; and

WHEREAS, among other things. Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit Organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to, San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, the Urban Corps of San Diego County has requested funding for costs associated with public health and safety services for its event titled, "La Vuelta End of Summer Cultural Festival"; and

WHEREAS, the Urban Corps of San Diego County is a certified local conservation corps and charter school whose mission is to provide young adults with a high school education, job training, and community service experience in conservation and recycling; and

WHEREAS, the 1st annual “La Vuelta End of Summer Cultural Festival” will provide members of the public with an experience with the unique cultural identity and community assets of Barrio Logan; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-23; and

WHEREAS, Council District 8 recommends an allocation of \$5,000 to the Urban Corps of San Diego County for the 1st annual “La Vuelta End of Summer Cultural Festival”; NOW THEREFORE,


BE IT RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an agreement between the City of San Diego and the Urban Corps of San Diego County (Agreement) in an amount not to exceed \$5,000 for the event described in this resolution, under the terms set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 311515.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from CD 8: Fund No. 200205, Cost Center No. 1414111219 GL 512059 to provide funds for the above referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23(3)(g), which provides: “An organization may not apply to receive funding for an event or program which has already occurred, nor any goods, supplies or materials which have already been purchased.”

BE IT FURTHER RESOLVED, by the Council of the City of San Diego that the allocation described herein is made to provide access to culture and the arts in the specific community of Barrio Logan and generally for residents of, and visitors to, San Diego, and to enrich the lives of the people of San Diego and build healthy, vital neighborhoods.
