A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN STEVEN AND CHRISTINE HASLET AND THE CITY OF SAN DIEGO

WHEREAS, Steven and Christine Haslet filed a complaint against the City of San Diego (City) for inverse condemnation following a sewer main break near their property located at 3760 Arizona Street, San Diego CA, on January 5, 2017, which resulted in property damage; and

WHEREAS, on September 12, 2017, the City Council by the following votes: Yeas, Districts 1, 2, 3, 4, 6, 7 8, 9; Nays, None; and Absent, 5, approved the settlement of the claim for an amount consistent with the amounts set forth below; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

- 1. A resolution authorizing the Mayor of his designee to pay the sum of \$67,000.00 from Water Fund No. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type including attorney fees, against City of San Diego, its agents and employees, arising from the property damage claim filed by Steven and Christine Haslet.
- 2. Authorizes the Chief Financial Officer to appropriate \$67,000 from Water Fund No. 700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizes the Comptroller to issue a check in the amount of \$67,000.00, made payable to the Blain Morrison Corporation Client Trust Account. APPROVED: MARA W.
