A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING AN AGREEMENT BETWEEN THE
CITY OF SAN DIEGO AND UNITED STATES NAVY TORT
CLAIMS UNIT.

WHEREAS, on November 23, 2015, USN Tort Claims Unit, filed suit against City of San Diego [City] alleging property damage arising from a water main break that occurred on August 5, 2015.

WHEREAS, the City Council in closed session on July 25, 2017, authorized settlement of the Claim for an amount consistent with the amounts set forth below;

NO, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

1. A resolution authorizing the Mayor or his designee to pay the sum of \$117,428.90 from Water Fund no. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the property damage claim filed by USN Torts Claims Unit.

2. Authorizes the Chief Financial Officer to appropriate and expend \$117,428.90 from the Water Fund No. 700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, deposit with the City Treasurer.

3. Authorizes the Comptroller to issue a check in the amount of \$117,428.90, made payable to United States Navy.

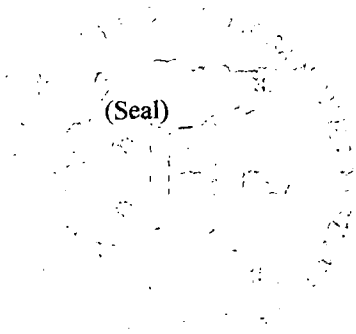


