- 1. A resolution authorizing the Mayor or his designee to pay the sum of \$117,428.90 from Water Fund no. 700011, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the property damage claim filed by USN Torts Claims Unit.
- 2. Authorizes the Chief Financial Officer to appropriate and expend \$117,428.90 from the Water Fund No. 700011, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, deposit with the City Treasurer.
