DATE OF FINAL PASSAGE FEB 06 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO GRANTING THE TWINING/LIM APPEAL IN PART AND MODIFYING THE HISTORICAL DESIGNATION OF THE SOUTH PARK HISTORIC DISTRICT AND DENYING THE TWINING/LIM APPEAL IN PART AND THE ROBERTS AND SORURBAKSH APPEALS AND AFFIRMING THE REMAINING PORTIONS OF THE HISTORICAL DESIGNATION OF THE SOUTH PARK HISTORIC DISTRICT.

WHEREAS, the Historical Resources Board (HRB) of the City of San Diego held a noticed public hearing on October 26, 2017 to consider the historical designation of the South Park Historic District located at various addresses within the Historic District boundaries, which includes the 407 resources bounded roughly by 28th Street to the west, Elm Street to the north, 31st Street to the East and A Street to the south (excluding 3017-3091 Elm Street, 1635 and 1639-1747 Fern Street, 1634-1729 Grove Street, 1670-1740 31st Street, and the Albert Einstein Charter Academy); and

WHEREAS, the HRB designated the South Park Historic District a historical resource and determined it is significant under HRB Criterion A as a special element of the City and Golden Hill's historical and architectural development. Specifically, the district is representative of real estate and streetcar suburban development in the first half of the 20th century, which is an important aspect of the historical and architectural development of Golden Hill. Contextually, the district relates to real estate marketing and the construction of infrastructure that accelerated development in the South Park neighborhood of Golden Hill by 1906; and it relates to the variety and evolution of architectural styles and trends in the pre-1950 period in San Diego represented in a range of socio-economic expressions, some of which were designed and built by Master

Architects and Builders. The degree of integrity exhibited by the district contributors makes it one of the best unified examples of an early 20th century streetcar suburb in the community. In addition to the buildings, the South Park District is further unified by Mexican Fan Palm trees lining many of the streets and sidewalks of the subdivision; and

WHEREAS, the HRB identified 300 properties as Contributing Resources to the South Park Historic District and designated them under HRB Criterion F; and

WHEREAS, the HRB identified 107 properties as Non-Contributing Resources to the South Park Historic District; and

WHEREAS, designated historical resources located within the City of San Diego are regulated by the Municipal Code (Chapter 14, Article 3, Division 2) as such any exterior modifications (or interior if any interior is designated) shall be approved by the City, this includes but is not limited to modifications to any windows or doors, removal or replacement of any exterior surfaces (i.e. paint, stucco, wood siding, brick), any alterations to the roof or roofing material, alterations to any exterior ornamentation and any additions or significant changes to the landscape/ site, for both contributing and non-contributing resources; and

WHEREAS, three appeals were filed by Gary Roberts (Roberts), David Twining and Marian Lim (Twining/Lim) and Shahriar Sorurbakhsh (Sorurbakhsh); and

WHEREAS, on appeal the City Council may by resolution affirm, reverse, or modify the determination of the HRB; and

WHEREAS, on appeal the City Council may reject the HRB's designation of a property as a historical resource on the basis of factual errors in materials or information presented to the HRB, violations of bylaws or hearing procedures by the HRB or individual member, or presentation of new information; and

WHEREAS, under Charter section 280(a)(2) this resolution is not subject to veto by the Mayor because this matter required the City Council to act as a quasi-judicial body where a public hearing was required by law implicating due process rights of individuals affected by the decision and where the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Twining/Lim appeal is granted in part by modifying the Historical Resources Board's historical resource designation of the South Park Historic District to change the property located at 1320 29<sup>th</sup> Street from a Contributing Resource to a Non-contributing Resource based upon the new information provided by the appellant. The new information provided by the appellant shows that the following modification were made to the property: extension of the roof along the primary façade approximately 18 inches; adding shingle siding over the original board and batten siding; removal of decorative knee braces along the eaveline; alterations of window openings and detailing; and removal of a trellis at the front porch, which may have dated to the district's period of significance. Cumulatively, these modifications have compromised the integrity of the building and its ability to convey the significance of the district.


BE IT FURTHER RESOLVED, that the Twining/Lim appeal is denied in part and the Roberts and Sorurbaksh appeals are denied.

BE IT FURTHER RESOLVED, that the HRB decision to designate the South Park Historic District, Register of Designated Historical Resources as **Site No. 1276**, (Exhibit D, on file with the City of San Diego Historical Resources Section), as a historical resource and determination that it is significant under HRB Criterion A as a special element of the City and Golden Hill's historical and architectural development is affirmed.

BE IT FURTHER RESOLVED, that the HRB identification of the other 299 properties, (Exhibits A and B, on file with the City of San Diego Historical Resources Section), excluding the property located at 1320 29<sup>th</sup> Street, as Contributing Resources to the South Park Historic District and designation under HRB Criterion F is affirmed. These properties will be subject to the U.S. Secretary of the Interior's Standards, the City of San Diego Historic Resources Regulations, and any applicable development and design guidelines as they relate to Contributing Resources, and will be eligible for all benefits of historic designation.

BE IT FURTHER RESOLVED, that the HRB identification of 107 properties as Non-Contributing Resources to the South Park Historic District is affirmed. With the addition of the property located at 1320 29<sup>th</sup> Street as a Non-Contributing Resource, there are a total of 108 Non-Contributing Resources, (Exhibit C, on file with the City of San Diego Historical Resources Section), in the South Park Historic District. These properties will be subject to the U.S. Secretary of the Interior's Standards, the City of San Diego Historic Resources Regulations, and any applicable development and design guidelines as they relate to Non-Contributing Resources.
