A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING MID-YEAR REVISIONS TO THE FISCAL YEAR 2018 BUDGET OF THE CITY OF SAN DIEGO.

WHEREAS, on June 9, 2017, the Mayor approved Resolution No. R-311158, approving the City's Fiscal Year 2018 Budget (2018 Budget); and

WHEREAS, on July 1, 2017, the City Council adopted Ordinance No. O-20837, entitled "An Ordinance Adopting the Annual Budget for Fiscal Year 2018 and Appropriating the Necessary Money to Operate the City of San Diego for Fiscal Year 2018." (Appropriation Ordinance); and

WHEREAS, on January 29, 2018, the Fiscal Year 2018 Mid-Year Budget Monitoring Report, (Mid-Year Report) was issued; and

WHEREAS, the Report projects a deficit of \$5.6 million relative to the adopted General Fund budget; and

WHEREAS, Section 15 of the Appropriation Ordinance authorizes the Chief Financial Officer to modify appropriations upon adopted City Council resolution, provided funding is available for such action and in accordance with finding source guidelines and applicable grant agreements; and

WHEREAS, the City Council desires to approve the proposed appropriation changes as described below and in accordance with the Report; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Chief Financial

Officer is authorized to revise the Fiscal Year 2018 Budget, as detailed in the Mid-Year Report,

as follows:

1. Increase expenditures and revenue appropriations in the Fleet Operating Fund

(720000) by up to \$1,400,000 for the change in how the Fire-Rescue Department

receives renewable diesel fuel. This increase is a pass through expense and has no

impact to the General Fund.

2. Increase expenditure and revenue appropriations in the Development Services

Fund (700036) by up to \$1,310,000 for overtime expenses due to vacancies to

ensure services are maintained and to assist with the implementation of the Accela

project.
