A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ACCEPTING THE REPORT OF THE
INDEPENDENT BUDGET ANALYST REGARDING CITY
COUNCIL BUDGET PRIORITIES FOR FISCAL YEAR 2019
AND DIRECTING THAT SAID REPORT BE DELIVERED TO
THE MAYOR'S OFFICE TOGETHER WITH THE
COUNCILMEMBERS' BUDGET PRIORITY MEMORANDA.

WHEREAS, pursuant to San Diego Charter section 69(b), each Councilmember is required to provide a memorandum to the Independent Budget Analyst setting for the Councilmember's budget priorities for the next fiscal year and the Independent is required to provide an analysis of the City Council's budget priorities and prepare a budget priorities resolution for City Council consideration; and

WHEREAS, the Independent Budget Analyst has prepared Report No. 18-01 REV., dated February 5, 2018 and entitled "FY 2019 City Council Budget Priorities" (Fiscal Year 2019 Budget Priorities Report), incorporating the budget priorities of the individual Councilmembers; and

WHEREAS, on February 1, 2018, the Budget and Government Efficiency Committee (Committee) voted to forward the Fiscal Year 2019 Budget Priorities Report to the City Council for approval, including certain recommendations made by the Committee and incorporated into the Fiscal Year 2019 Budget Priorities Report; and

WHEREAS, pursuant to San Diego Charter sections 280(a)(1) and 295(b), this resolution is exclusively within the purview of the City Council and may be passed by the City Council on


the date of introduction, which date shall be deemed the date of final passage, and is not subject to veto by the Mayor; NOW, THEREFORE,

BE IT RESOLVED by the Council of the City of San Diego that Independent Budget Analyst Report No. 18-01 REV. (Report), concerning budget priorities for the Fiscal Year 2019 Budget, is hereby accepted, and the Independent Budget Analyst is hereby directed to deliver the Report, together with each Councilmembers' Fiscal Year 2019 Budget Priorities Memorandum, to the Mayor's Office for consideration during the preparation of the Fiscal Year 2019 proposed budget.

BE IT FURTHER RESOLVED, that in addition to the priorities set forth in the Report, an additional priority is the inclusion of one full-time employee in the Council Administration Department.
