A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN LYNN K. WHITEHOUSE AND THE CITY OF SAN DIEGO

WHEREAS, Lynn K. Whitehouse, an individual filed suit against the City of San Diego [City] alleging personal injuries arising from a trip and fall that occurred at 3034 University Avenue. Plaintiff brought suit in the San Diego Superior Court. The suit is entitled *Lynn K. Whitehouse v. City of San Diego, et al.*, Case No 37-2016-00038739-CU-PO-CTL [Litigation]; and

WHEREAS, on December 15, 2017, the City Council by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7 8, 9; Nays, None; and Absent, None, approved the settlement of the claim for an amount consistent with the amounts set forth below; NOW THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

1. A resolution authorizing the Mayor or his designee to pay the sum of \$137,500.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury complaint filed by Lynn Whitehouse.

2. Authorizes the Chief Financial Officer to expend \$137,500.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizes the Comptroller to issue a check in the amount of \$137,500.00, made payable to Lynn Whitehouse and Klein DeNatale Goldner Cooper Rosenlieb & Kimball, LLP.


