A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DETERMINING THAT PRIOR ENVIRONMENTAL DOCUMENTS ADEQUATELY ANALYZED THE PROPOSED AMENDMENTS TO THE AFFORDABLE HOUSING DENSITY BONUS REGULATIONS.

WHEREAS, the City Council, as the Lead Agency and using its independent judgment, by Resolution Nos. R-289458, R- 303472, and R-310176 adopted on November 18, 1997, March 10, 2008, and December 7, 2015, respectively, certified Environmental Impact Report No. EIR No. 96-0333/SCH No. 96081056; the General Plan PEIR No. 104495/SCH No. 2006091032 and associated Addendums; and the Climate Action Plan PEIR No. 416603/SCH No. 2015021053 and associated Addendum. (California Environmental Quality Act (CEQA) Documents), copies of which are on file with the Office of the City Clerk; and

WHEREAS, in connection with the consideration of the Land Development Code, General Plan, and Climate Action Plan Projects, the City Council considered the issues discussed in the CEQA Documents; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the information contained in the CEQA Documents, including any comments received during the public review process, have been reviewed and considered by this Council and it is determined that no substantial changes or new information of substantial importance within the meaning of CEQA Guideline section 15162 would warrant any additional environmental review in connection with approval of the amendments to the Affordable Housing Density Bonus Regulations.

BE IT FURTHER RESOLVED, that the City Clerk is directed to file a Notice of Determination (NOD) with the Clerk of the Board of Supervisors for the County of San Diego regarding the above action.

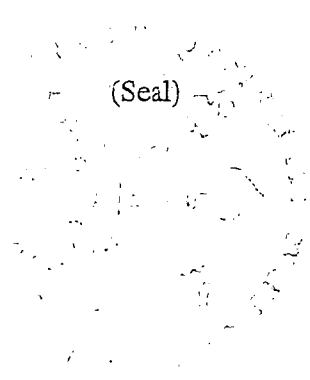
