A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$25,000 TO THE SAN DIEGO HOUSING FEDERATION FOR THE SAN DIEGO COMPANION UNIT TOOLKIT, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the San Diego Housing Federation has requested funding for the San Diego Companion Unit Toolkit; and

WHEREAS, the requested funding will be used to cover the costs associated with the creation of the toolkit; and

WHEREAS, the San Diego Housing Federation's request for funding for the San Diego Companion Unit Toolkit will benefit public by encouraging homeowners to build companion units that increase the supply of affordable housing in the City, as well as providing housing options for elderly and homeless populations; and

WHEREAS the award of Community Projects, Programs and Services funding does not constitute City-approval or sponsorship of the Companion Unit Toolkit or any of the designs

provided therein, nor pre-approval for any projects built using the Companion Unit Toolkit, which will be subject to the City's usual permitting procedures for companion units; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 7 recommends an allocation of \$25,000 to the San Diego Housing Federation for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2018 City Council Allocations Agreement between the City of San Diego and the San Diego Housing Federation (Agreement) in an amount not to exceed \$25,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 311602.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$25,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1107110007 CD 7, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates
