DATE OF FINAL PASSAGE APR 02 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO REGARDING THE SALARIES OF THE
COUNCIL AND MAYOR FOR FISCAL YEAR 2019 AND
FISCAL YEAR 2020.

WHEREAS, section 41.1 of the Charter of the City of San Diego (Charter) established the Salary Setting Commission (Commission) to recommend to the San Diego City Council (Council) the enactment of an ordinance for salaries for the Mayor and Council; and

WHEREAS, section 12.1 pertaining to Councilmember salaries, and section 24.1 pertaining to the Mayor's salary, require that the Commission submit its recommendation on or before February 15 of every even numbered year, with salaries to be effective the following July 1 for a two-year period; and

WHEREAS, between November 2017 and February 2018, the Commission reviewed comprehensive data compiled by the City of San Diego Personnel Department staff and met on five occasions, inviting participation and comment from community planning groups, members of the media, chambers of commerce, employee labor organizations, and members of the public to determine and ascertain facts sufficient to establish salary levels to recommend to the Council for adoption by ordinance, as required by the Charter; and

WHEREAS, the Commission, pursuant to the Charter mandate, presented its recommendations in a report to the Mayor and Council dated February 2, 2018; and

WHEREAS, the Commission recommended the following salaries for the Mayor and City Council:

Current	\$75,386	\$100,464
July 1, 2018	\$75,386	\$100,464
July 1, 2019	\$80,361	\$107,095

WHEREAS, pursuant to sections 12.1 and 24.1 of the Charter, the Council may adopt the salaries as recommended by the Commission, or in some lesser amount, but in no event may it increase the amount; and

WHEREAS, upon review of the Commission's recommendation and after a public discussion, the Council voted 7-2 not to accept the recommendation of the Commission and to have the salaries of Mayor and Council remain unchanged for the two-year period; NOW


THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the City Attorney is hereby directed, pursuant to section 41.1 of the Charter, to incorporate the following amounts in

the annual salary ordinance for Fiscal Year 2019, to be effective July 1, 2018, and the annual salary ordinance for Fiscal Year 2020, to be effective July 1, 2019:
