DATE OF FINAL PASSAGE MAR 26 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO TO CONCUR WITH THE RECOMMENDED  
REDUCTION OF TAXICAB INSURANCE REQUIREMENTS  
PROPOSED BY THE SAN DIEGO METROPOLITAN  
TRANSIT SYSTEM.

WHEREAS, the San Diego Metropolitan Transit System (MTS) administers and regulates taxicabs on behalf of the City of San Diego (City); and

WHEREAS, in 2010, at the request of MTS taxicab permit holders, MTS raised the required insurance limits for a taxicab from \$300,000 to \$1,000,000 (effective for all insurance renewals after January 1, 2011); and

WHEREAS, the taxicab market has undergone significant change since January 1, 2011, including a reduction in permitted taxicabs, increased operation costs, and competition from transportation network companies; and


WHEREAS, based on feedback received from the local taxicab industry and the MTS Taxicab Advisory Committee, it has been requested that the insurance limit requirement for taxicabs be reduced to \$350,000; and

WHEREAS, the City contract with MTS for the administration of taxicabs requires that MTS shall not alter a fundamental policy or regulation without City approval; and

WHEREAS, MTS requests and recommends that the City Council approve the action proposed by MTS to lower the taxicab insurance limit requirements to \$350,000; NOW,  
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to communicate to the MTS Chief Executive Officer that the City concurs in the recommendation that MTS taxicab insurance requirements be reduced to \$350,000.
