A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTELMENT AGREEMENT BETWEEN HEATHER SLAVEY AND THE CITY OF SAN DIEGO

WHEREAS, on December 6, 2016, HEATHER SLAVEY filed suit against Christopher Stanley and the City of San Diego alleging personal injuries arising from a motor vehicle accident on Camino Del Norte, in the City of San Diego, on December 23, 2015. Plaintiff brought suit in the San Diego Superior Court. The suit is entitled *Heather Slavey v. Christopher Stanley, et al.*: San Diego Superior Court Case No. 37-2016-00042724-CU-PA-CTL; and

WHEREAS, in Closed Session on February 6, 2018, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and All Present, approved the Settlement; and

WHEREAS, the City Council in Closed Session on February 6, 2018, authorized settlement of the Litigation for an amount consistent with the amounts set forth below; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

1. A resolution authorizing the Mayor or his designee to pay the sum of \$600,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the personal injury complaint filed by Heather Slavey, entitled *Heather Slavey v. City of San Diego*, San Diego Superior Court Case No. 37-2016-00042724-CU-PA-CTL.

- 2. Authorizes the Chief Financial Officer to expend \$600,000.00 from Public Liability Fund No. 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
- 3. Authorizes the Comptroller to issue a check in the amount of \$600,000.00, made payable to Fox Law, APC Client Trust Account.
