DATE OF FINAL PASSAGE APR 24 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO APPROVE AND EXECUTE A FIVE YEAR AGREEMENT WITH CITYGATE ASSOCIATES, LLC FOR AS NEEDED CONSULTING SERVICES AND AUTHORIZING THE CHIEF FINANCIAL OFFICER TO EXPEND AN AMOUNT NOT TO EXCEED \$850,000 FOR THAT AGREEMENT.

WHEREAS, Citygate Associates, LLC (Citygate) has extensive experience conducting studies throughout California and the United States, particularly with fire department deployment analyses, emergency medical services, costing and financial analysis, and development of short- and long-term strategies; and

WHEREAS, because of Citygate’s technical expertise in these areas, the Fire-Rescue Department (SDFD) retained the services of Citygate through a sole source procurement to conduct and complete various comprehensive assessments of essential departmental operations; and

WHEREAS, the City desires to combine all agreements for current and future Citygate studies into this Agreement and to obtain City Council approval for this Agreement pursuant to San Diego Municipal Code section 22.3207; and


WHEREAS, the costs for the as-needed consultant services shall not exceed \$850,000 over a five year Agreement term and will be budgeted in the General Fund; NOW,

THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to approve and execute a five year agreement with Citygate Associates, LLC for as needed consultant services in an amount not to exceed \$850,000.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$850,000 for as needed consultant services, contingent upon the adoption of the Annual Appropriations Ordinance for the applicable fiscal year, and contingent upon the Chief Financial Officer first furnishing a certificate certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

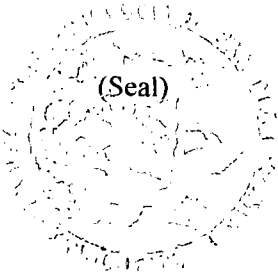
