A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$2,500 TO LA JOLLA ART AND WINE FESTIVAL FOUNDATION FOR THE LA JOLLA ART AND WINE FESTIVAL, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCE TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, entitled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by San Diego Resolution R-307625; and

WHEREAS, among other things, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, the La Jolla Art and Wine Festival Foundation has requested funding for the La Jolla Art and Wine Festival; and

WHEREAS, the requested funding will be used for advertising on Facebook and local radio stations; and

WHEREAS, the La Jolla Art and Wine Festival Foundation's request for funding for the La Jolla Art and Wine Festival will benefit the public by providing a two day festival that is known as one of the West Coast's most prestigious art and wine festivals, attracting approximately 40,000 attendees. The event is free to the public and features wine and beer from

premier wineries and craft breweries. The work of over 200 established artists from San Diego, Los Angeles, Orange County, Baja, and more is displayed. The event further also offers live entertainment, a silent auction, food court, and child activities. To ensure high attendance, the foundation engages in a robust marketing campaign; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-23; and

WHEREAS, Council District 1 recommends an allocation of \$2,500 to the La Jolla Art and Wine Festival Foundation for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-23(3)(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an Agreement between the City of San Diego and the La Jolla Art & Wine Festival Foundation (Agreement) in an amount not to exceed \$2,500 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 311649

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$2,500 from Council District 1: Fund No. 200205, Cost Center 1414111212 GL 512059, to provide funds for the above-referenced Agreement, contingent upon

the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
