A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$3,380 TO FRIENDS OF TECOLOTE CANYON FOR ENVIRONMENTAL AND CULTURAL EDUCATION, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Friends of Tecolote Canyon has requested funding for Environmental and Cultural Education; and

WHEREAS, the requested funding will be used for craft materials and outreach including posters, fliers, display signs, and electronic media; and

WHEREAS, the Friends of Tecolote Canyon's request for funding for Environmental and Cultural Education will benefit public by providing opportunities for the community to learn about the area's animals, plants, ecology, and Kumeyaay history and culture; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 2 recommends an allocation of \$3,380 to the Friends of Tecolote Canyon for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation

described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06,

section 3(g), which provides: "An organization may not apply to receive funding for an event or

program which has already occurred, nor any capital improvement, goods, supplies, materials, or

equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and

directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services

FY 2018 City Council Allocations Agreement between the City of San Diego and the Friends of

Tecolote Canyon (Agreement) in an amount not to exceed \$3,380 for the project described in this

resolution, under terms and conditions set forth in the Agreement on file in the Office of the City

Clerk as Document No. RR- 311652

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend

an amount not to exceed \$3,380 from the Community Projects, Programs, and Services budget

Fund No. 100000, Cost Center 1102110002, CD 2, to provide funds for the above-referenced

Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates

certifying that the funds necessary for expenditure are, or will be, on deposit with the City

Treasurer.
