DATE OF FINAL PASSAGE APR 16 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$12,000 TO MANA DE SAN DIEGO FOR THE LATINA SUCCESS CONFERENCE AND LEADERSHIP PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the MANA de San Diego has requested funding for the Latina Success Conference and Leadership Program; and

WHEREAS, the requested funding will be used to support the Latina Success Conference and Leadership Program for printing, supplies, accessories, one computer, and speaker fees; and

WHEREAS, the MANA de San Diego's request for funding for the Latina Success Conference and Leadership Program will benefit public by providing programs and services that educate and support San Diego Latinas at every stage of their educational and professional journey so that they can succeed and help grow the San Diego economy; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council Districts 2, 4, and 9 recommend a total allocation of \$12,000 to the MANA de San Diego for the purposes set forth in this resolution, attributed as follows: Council District 2 – \$5,000; Council District 4 – \$5,000; and Council District 9 –\$2,000; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.


BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: “An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased.”

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2018 City Council Allocations Agreement between the City of San Diego and the MANA de San Diego (Agreement) in an amount not to exceed \$12,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR- 311655.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$5,000 from Council District 2: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1102110002; \$5,000 from Council District 4: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1104110004; \$2,000 from Council District 9: Community Projects, Programs and Services budget Fund No. 100000, Cost Center No. 1109110009, all to provide funds for the

above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
