A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$6,000 TO COOPER FAMILY FOUNDATION FOR THE JUNETEENTH CELEBRATION OF BLACK INDEPENDENCE DAY, PURSUANT TO COUNCIL POLICY 100-23, "CITY COUNCIL FUNDING FOR ARTS, CULTURE AND COMMUNITY FESTIVALS WITH DISCRETIONARY TRANSIENT OCCUPANCE TAX ALLOCATION."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-23, entitled "City Council Funding of Arts, Culture and Community Festivals with Transient Occupancy Tax Allocation" on August 13, 2012, by San Diego Resolution R-307625; and

WHEREAS, among other things, Council Policy 100-23 provides a procedure and uniform requirements for awarding funds to and contracting with private non-profit organizations that produce programs, projects and events that (i) provide access to excellence in culture and the arts for residents of, and visitors to San Diego, and (ii) enrich the lives of the people of San Diego and build healthy, vital neighborhoods; and

WHEREAS, the Cooper Family Foundation has requested funding for the Juneteenth Celebration of Black Independence Day; and

WHEREAS, the requested funding will be used to cover the costs of the artist and art wall supplies; and

WHEREAS, the Cooper Family Foundation has led the Juneteenth Celebration of Black Independence Day for over 50 years. The Juneteenth celebration recognizes the date June 19, 1865, when the message that slavery was abolished reached the last of the southern slaves. While

the holiday is not yet nationally recognized, it is widely recognized and celebrated throughout the African American community. The foundation intends on growing this celebration in the San Diego community. This event will benefit the public by offering an educational program focused on cultural awareness and appreciation, cultural dances, an art wall, presentations, live music, barbeque, diabetes screenings, health information, and a child fun zone- all free to the public; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-23; and

WHEREAS, Council District 8 recommends an allocation of \$6,000 to the Cooper Family Foundation for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, an Agreement between the City of San Diego and the Cooper Family Foundation (Agreement) in an amount not to exceed \$6,000 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-311665.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$6,000 from Council District 8: Fund No. 200205, Cost Center 1414111219 GL 512059, to provide funds for the above-referenced Agreement, contingent upon

the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
