A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING AN APPOINTMENT AND REAPPOINTMENTS TO THE SMALL BUSINESS ADVISORY BOARD.

(1) small business owner; (2) accounting, financial-lending, legal or economic backgrounds; and
(3) advocates of small business interests with governmental agencies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment and reappointments by the Mayor of the City of San Diego, to serve as members of

the Small Business Advisory Board, for terms expiring as indicated, are made and hereby confirmed:
