A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$11,115 TO PENASQUITOS LITTLE LEAGUE FOR THE YOUTH BASEBALL PROGRAM, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Penasquitos Little League, also known as the Rancho Penasquitos Little League (RPLL), has requested funding for the Youth Baseball Program; and

WHEREAS, the requested funding will be used for physical improvements to facilities and the purchase of baseball equipment, uniforms, and backstop padding; and

WHEREAS, the RPLL's request for funding for the Youth Baseball Program will benefit public by providing the community access to safe and affordable baseball programs for youth that promote healthy living, teamwork, and civic responsibility; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 5 recommends an allocation of \$11,115 to the RPLL for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2018 City Council Allocations Agreement between the City of San Diego and the Penasquitos Little League aka Rancho Penasquitos Little League (Agreement) in an amount not to exceed \$11,115 for the project described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$11,115 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1105110005 GL 512059, to provide funds for the above-referenced Agreement, contingent upon the Chief Financial Officer first furnishing one or
