DATE OF FINAL PASSAGE APR 25 2018

A RESOLUTION ACCEPTING THE DEDICATION OF STREET RIGHT-OF-WAY FOR A PORTION OF NOBEL DRIVE.

WHEREAS, in 1874 the City of San Diego (City) acquired Pueblo Lots 1304 and 1306 of Miscellaneous Map No. 36, which have been parceled out and are now referred to as Assessor Parcel Numbers 345-011-24, 345-021-03, and 345-021-02 (City Property); and

WHEREAS, in 1999 the City entered into a Cooperative Agreement (Agreement) with the State of California Department of Transportation (Caltrans) and granted Caltrans easement rights for the construction of the Nobel Drive Extension and Interchange Improvements; and

WHEREAS, as part of the Agreement the City agreed to construct 1.14 acres of Nobel Drive east of the I-805 freeway and 6.31 acres of Nobel Drive west of the I-805 freeway; and

WHEREAS, although the street improvement constituting Nobel Drive, over and on the City Property, were completed years ago, this section of Nobel Drive was never formally dedicated as right-of-way; and


WHEREAS, City of San Diego Fire-Rescue Department proposes to build Fire Station 50 on Nobel Drive and requires Nobel Drive to be formally dedicated as right-of-way for street purposes in order to finalize the design of the fire station; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, or his designee, is authorized to take all actions necessary to facilitate the dedication, for street purposes, of that area described as a portion of Pueblo Lots 1304 & 1306, according to

Miscellaneous Map No. 36; filed in the office of the County Recorder of San Diego County on November 14, 1921, used to construct that portion of Nobel Drive.

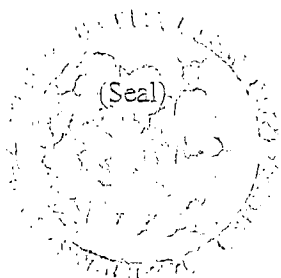
