DATE OF FINAL PASSAGE APR 24 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO EXTENDING THE TEMPORARY SPECIAL ISSUES COUNCIL COMMITTEE NAMED THE SELECT COMMITTEE ON HOMELESSNESS FOR AN ADDITIONAL SIX MONTHS FROM JULY 1, 2018 THROUGH DECEMBER 31, 2018.

WHEREAS, Rule 9 of the Permanent Rules of the Council provides that the Council President may, at any time, place on the Adoption Agenda a resolution establishing a temporary rule that, for the time being, has the effect of a standing rule; and

WHEREAS, the City Council (Council) adopted Resolution R-311100 on May 16, 2017 establishing a Special Issues Committee named the Select Council Committee on Homelessness (Committee); and

WHEREAS, Temporary Rule 6.11.3 was added to the Rules of the Council and has the effect of a standing rule until the Committee completes its objectives and is dissolved; and

WHEREAS, the Committee was established to work on issues related to homelessness in the City of San Diego, with work to include updating the City's Comprehensive Homeless Policy (Council Policy 000-51), attempting to clarify and strengthen the City's role in addressing homelessness, and focusing on current and proposed programs, solutions, and funding mechanisms; and

WHEREAS, the resolution establishing the Committee and Temporary Rule 6.11.3 authorizes the Committee to meet for a one-year period from June 2017 through June 2018, with an option to extend for an additional six months from July 2018 through December 2018 if the Committee has not completed the objectives for which it was created, contingent upon Council approval; and


WHEREAS, the Committee has not completed the objectives for which it was created and the Council wishes to authorize the Committee to meet through December 2018; and

WHEREAS, under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and not affecting the administrative service of the City under the control of the Mayor; NOW,

THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Special Issues Committee named the Select Council Committee on Homelessness provided by temporary Rule 6.11.3 of the Rules of the Council, is authorized to meet and continue its work for an additional six months beginning July 1, 2018.
