A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ALLOCATING \$10,000 TO ASIAN PACIFIC ISLANDER COMMUNITY ACTIONS (APICA) FOR THE PARADISE HILLS STRENGTHENING PROJECT, PURSUANT TO COUNCIL POLICY 100-06, "CITY COUNCIL FUNDING OF COMMUNITY PROJECTS, PROGRAMS, AND SERVICES."

WHEREAS, the San Diego City Council (City Council) adopted Council Policy 100-06, titled "City Council Funding of Community Projects, Programs and Services" on June 28, 2011, by San Diego Resolution R-306903 (July 7, 2011); and

WHEREAS, among other things, Council Policy 100-06 provides a procedure and uniform requirements for awarding funds to and contracting with non-profit organizations and public agencies for one-time community, social, environmental, cultural, or recreational needs which serve a lawful public purpose; and

WHEREAS, the Asian Pacific Islander Community Actions (APICA) has requested funding as fiscal agent for the Paradise Hills Strengthening Project; and

WHEREAS, \$5,000 of the requested funding will be used for program staffing and equipment rentals for the FilAmFest,

WHEREAS, \$2,500 of the requested funding will be used for capital equipment and rentals for the Paradise Hills Night Market,

WHEREAS, \$2,500 of the requested funding will be used for capital equipment for ProjectREO's Trunk or Treat and Holiday in the Hills; and

WHEREAS, the Asian Pacific Islander Community Action's request for funding for the Paradise Hills Neighborhood Strengthening Project will benefit public by celebrating the strengths, talent, and business opportunities lying within the community and reaching across

various ethnic and cultural backgrounds within the district for cross cultural understanding and civic engagement; and

WHEREAS, it is the determination of the City Council that the above-described program fits within the parameters of Council Policy 100-06; and

WHEREAS, Council District 4 recommends an allocation of \$10,000 to the Asian Pacific Islander Community Actions for the purposes set forth in this resolution; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the allocation described in this resolution is made for a public purpose.

BE IT FURTHER RESOLVED, that the City Council waives Council Policy 100-06, section 3(g), which provides: "An organization may not apply to receive funding for an event or program which has already occurred, nor any capital improvement, goods, supplies, materials, or equipment which have already been purchased."

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized and directed to execute, for and on behalf of the City, a Community Projects, Programs, and Services FY 2018 City Council Allocations Agreements between the City of San Diego and the Asian Pacific Islander Community Actions (APICA) (Agreements) in an amount not to exceed \$10,000 for the projects described in this resolution, under terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR
311723

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$10,000 from the Community Projects, Programs, and Services budget Fund No. 100000, Cost Center 1104110004, GL 512059; \$5,000 for FilAm Fest, \$2,500 for Paradise Hills Night Market, and \$2,500 for ProjectREO's Trunk or Treat and Holiday in the Hills to provide funds for the above-referenced Agreements, contingent upon the Chief Financial

Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
