A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING EXECUTION OF AN ASNEEDED ENGINEERING AGREEMENT FOR ENGINEERING SUPPORT WITH AECOM TECHNICAL SERVICES, INC. FOR THE UTILITIES UNDERGROUNDING PROGRAM (H176956).

WHEREAS, AECOM Technical Services, Inc. (AECOM) has been selected for one of two As-Needed Professional Engineering Support contracts (Agreement) with the City's Transportation & Storm Water Department (TSWD), Right-of-Way Coordination Division (ROWD) which will utilize AECOM to support enhanced performance of the Utilities Undergrounding Program currently budgeted at \$60 million using the Underground Surcharge Fund with work funded and authorized on a task order basis for a total contract amount not to exceed \$4,000,000 and a contract duration of five years; and

WHEREAS, the TSWD will assign a contract administrator to manage execution of task orders within the total contract not-to-exceed amount of \$4,000,000 and within the contract duration of five years and a separate Council item is being routed concurrently to approve a second contract of the same scope, capacity and duration with the combined contract capacity of the two contracts estimated to be sufficient to support planned enhancements to the Utilities Undergrounding Program; enhancements which include increasing the rate at which existing overhead utilities are converted to underground utilities, improving customer satisfaction by means of reduced project delays, increased transparency and customer communications, and improved coordination with other projects; and

WHEREAS, the selection of AECOM for performance of these services is based on advertising a Request for Proposals (RFP) in the San Diego Daily Transcript and on the City's "PlanetBids" website, shortlisting of the nine responsive firms using the evaluation criteria listed

in the RFP, and conducting interviews for the seven shortlisted firms in conformance with

Council Policy 300-7; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor, or his designee, is authorized to execute, for and on behalf of the

City, a five-year agreement with AECOM to provide as-needed professional consultant services

in an amount not to exceed \$4,000,000, in connection with the Utilities Undergrounding Program

(H176956), under the terms and conditions set forth in the Agreement, on file in the Office of the

City Clerk as Document No. RR- 311739.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed

\$4,000,000 over a five-year period for task order services under the AECOM agreement,

contingent upon the approval of the annual Appropriation Ordinance for the applicable fiscal

year, and contingent upon the Chief Financial Officer first furnishing one or more certificates

certifying that funds necessary for expenditures are, or will be, on deposit with the City Treasury.

That the Chief Financial Officer is authorized to expend \$1,000 from the 3.

Undergrounding Surcharge Fund (Fund 200217), for the purpose of executing this agreement

and meeting minimum contract requirements.
