A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH AECOM TECHNICAL SERVICES, INC. FOR THE PREPARATION OF A GROUNDWATER MANAGEMENT PLAN FOR THE SAN DIEGO FORMATION, CONTRACT NO. H156306.

WHEREAS, in 2014, the California Legislature and the Governor passed into law the Sustainable Groundwater Management Act (SGMA), which provides a new framework for best management of groundwater resources in California by the formation of Groundwater Sustainability Agencies (GSAs) and through the subsequent preparation and implementation of Groundwater Sustainability Plans (GSPs); and

WHEREAS, under the existing Agreement, AECOM Technical Services, Inc. was scoped to research, develop and prepare a GMP for the Coastal Plain of San Diego Formation Groundwater Basin (Basin), and the primary purpose of this Amendment is to expand the scope of services to complete a GSP for the Basin in order to fulfill the SGMA requirements; and

WHEREAS, this action will authorize the Mayor to execute Amendment No. 1 to the Agreement with AECOM Technical Services, Inc. for preparation of the Groundwater Management Plan for the Basin, in an amount not to exceed \$306,894, bringing the total Agreement cost to \$1,256,868; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Mayor, or his designee, is authorized to execute Amendment No. 1 to the Agreement with AECOM Technical Services, Inc., for the preparation of a Groundwater Management Plan for the Basin, in an amount not to exceed \$306,894, bringing the total Agreement cost to \$1,256,868; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$306,894 from Water Utility Operating Fund 700011, for the purpose of funding Amendment No. 1 to the Agreement for Groundwater Management Plan consulting
