SAN DIEGO DESIGNATING THE BLOCK OF 5825 IMPERIAL
AVENUE BETWEEN THE INTERSECTIONS OF VALENCIA
PARKWAY AND GANNET STREET LOCATED IN THE
VALENCIA PARK COMMUNITY TO BE KNOWN AS
BISHOP GEORGE D. MCKINNEY AVENUE.
