A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING REVISIONS TO THE FISCAL YEAR 2018 CAPITAL IMPROVEMENTS PROGRAM BUDGET OF THE CITY OF SAN DIEGO RELATED TO APPROPRIATE AND EXPEND PROCEEDS FROM THE GENERAL FUND COMMERCIAL PAPER NOTES.

WHEREAS, on June 9, 2017, the Mayor approved Resolution No. R-311158, approving the City's Fiscal Year 2018 Budget (2018 Budget); and

WHEREAS, on July 1, 2017, the City Council adopted Ordinance No. O-20837, entitled "An Ordinance Adopting the Annual Budget for Fiscal Year 2018 and Appropriating the Necessary Money to Operate the City of San Diego for Fiscal Year 2018." (Appropriation Ordinance); and

WHEREAS, the 2018 Budget includes the annual allocation for the City's multi-year Capital Improvements Program Budget (CIP Budget); and

WHEREAS, the CIP Budget contains anticipated funding that is not included in the annual budget because funding sources either require additional City Council approval, such as bond financing or grants, or because funding sources are uncertain; and

WHEREAS, the Public Facilities Financing Authority (Authority) on behalf of the City of San Diego (City) has approved the issuance of City General Fund-backed Commercial Paper notes (Commercial Paper), in an amount not to exceed \$80.5 million, the proceeds of which can be used to fund various General Fund capital improvements; and

WHEREAS, the Chief Financial Officer requests authority to increase appropriations in the CIP Budget to allow for the appropriation of the proceeds of the Commercial Paper, whenever received by the City, and to expend such proceeds in accordance with this Resolution; and

WHEREAS, Section 15 of the Appropriation Ordinance authorizes the Chief Financial Officer to modify appropriations upon adopted City Council resolution, provided funding is available for such action and in accordance with funding source guidelines and applicable grant agreements; and

WHEREAS, the City Council desires to approve the proposed appropriations as described below; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Chief Financial Officer is authorized to revise the Fiscal Year 2018 Budget, to provide for the appropriation and expenditure of Commercial Paper proceeds as follows:

- 9. \$540,000 to CIP S00880 Miramar Road I-805 Easterly Ramps
- 10. \$450,873 to CIP \$17000 Balboa Park Bud Kearns Aquatic Complex Imp
- 11. \$450,000 to CIP AIE00002 Guard Rails
- 12. \$443,306 to CIP S15035 EB Scripps Park Comfort Station Replacement
