A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE CONTRACT FOR THE RETENTION OF BURKE, WILLIAMS & SORENSEN, LLP AS OUTSIDE COUNSEL TO REPRESENT AND DEFEND THE CITY IN LITIGATION INVOLVING THE CASE OF MARLEA DELL'ANNO v. CITY OF SAN DIEGO.

WHEREAS, the City of San Diego (City) is a named defendant in the lawsuit entitled Marlea Dell'Anno v. City of San Diego, et al., San Diego Superior Court Case No. 37-2017-00000118-CU-OE-CTL (Dell'Anno Case); and

WHEREAS, the City desires to retain the law firm of Burke, Williams & Sorensen, LLP (Law Firm) to defend the City on the Dell'Anno Case; and

WHEREAS, on April 24, 2018, the Purchasing Agent approved the Request and Certification for Sole Source Procurement; and

WHEREAS, the agreement for legal services (Agreement) between the City and Law Firm is for an amount not to exceed \$250,000 and shall run from the date the last party signs the Agreement and it is approved by the City Attorney in accordance with San Diego Charter section 40, until the scope of services defined in the Agreement is complete, but not for a term exceeding five years from the date of the initial agreement, unless an extension is approved by ordinance of the City Council pursuant to San Diego Charter section 99; and

WHEREAS, the funding for the Agreement shall be borne by the Public Liability Fund 720045; and

WHEREAS, this matter was heard by the City Council in closed session on April 10, 2018; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council approves the contract for the retention of the Law Firm as outside counsel on the Dell'Anno Case and authorizes and directs the Mayor or his designee to execute the Agreement with the Law Firm.

BE IT FURTHER RESOLVED, by the City Council of the City of San Diego, that the Council authorizes the Chief Financial Officer or his designee to appropriate and expend an amount up to \$250,000 from the Public Liability Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
