DATE OF FINAL PASSAGE MAY 30 2018

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT AGREEMENT BETWEEN ANTHONY CARANO, 3970 INGRAHAM STREET CONDOMINIUMS HOMEOWNERS ASSOCIATION and THE CITY OF SAN DIEGO.

WHEREAS, on September 30, 2016, ANTHONY CARANO filed suit against the City of San Diego [City] alleging personal injuries arising from an incident that occurred on January 31, 2016. Plaintiff brought suit in the Superior Court for the County of San Diego. The suit is entitled *Anthony Carano v. City of San Diego, et al.*, Superior Court Case No. 37-2016-00034226-CU-PO-CTL [Litigation]; and

WHEREAS, in Closed Session on April 10, 2018, the City Council, by the following votes: Yeas, District(s) 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None and absent, District(s) 1, approved the settlement; and

WHEREAS, the City Council in closed session on April 10, 2018, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement; NOW, THEREFORE,


BE IT RESOLVED, by the City Council of the City of San Diego, that the Council authorizes:

1. The sum of \$700,000.00 to be paid from the Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.

2. Authorizing the Chief Financial Officer to appropriate and expend \$700,000.00 from the Public Liability Fund, Fund 720045, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. Authorizing the Comptroller to issue a check in the amounts of: \$700,000.00 made payable to Girardi Keese Client Trust Account and Anthony Carano.
